**FUJIFILM Valentine's Day Pink X100T Sweepstakes**  
**Official Rules**

**1. No Purchase Necessary. NO PURCHASE IS NECESSARY** to enter or win the FUJIFILM Valentine's Day Pink X100T Sweepstakes (the "Sweeps"). This Sweeps is being conducted by FUJIFILM North America Corporation of 200 Summit Lake Drive, Valhalla, NY 10595 ("Sponsors"). **2. Time Period.** The Sweeps begins at 5:00 p.m. Eastern Time (ET) on 1/13/2016 and ends at 11:59 p.m. ET on 2/14/2016 (the "Sweeps Period"). No entries will be accepted after expiration of the Sweeps Period. The Sweeps is open to all legal residents of the 50 United States and Washington D.C. who are at least 18 years of age at time of entry. Employees and the immediate family members of Sponsors (meaning spouses, parents, siblings and children living in the same household) are not eligible to enter or win. **Void in Puerto Rico and wherever else prohibited by law.** This Sweeps is subject to all applicable laws.

**4. How to Enter the Sweeps.** This is an on-line Sweeps. To enter, during the Sweeps Period, visit [www.fujifilmsweepstakes.com](http://www.fujifilmsweepstakes.com) and enter your name, email address, birthdate, phone number, and state of residence on the official entry form where referenced. As part of the entry process, entrants will have the option to "Opt In" to receive Fujifilm promotional materials and offers from time to time. "Opting in" will not improve your chance of winning a prize in the Sweeps. Upon completion of the entry form, click "Submit" to submit your entry. Limit 1 entry per person. Entry must be received during the Sweeps Period to be eligible.

Failure to fully and correctly complete and submit the entry form will render your entry ineligible. By entering, entrants in the Sweeps agree to be fully bound by these Official Rules and Fujifilm's determinations, which in all instances shall be final. By entering, each entrant agrees to release Fujifilm from all liability relating to this Sweeps, or participation in it. Fujifilm will not answer any communications regarding entries. No responsibility is assumed by Fujifilm for late or misdirected entries or for transmission or submission errors. The grand prize winner will receive one (1) limited release pink FUJIFILM X100T Camera. Total approximate value of grand prize is \$1,499.99 (USD). The grand prize is not available on the market and may not be of identical quality and characteristics of the FUJIFILM X100T cameras offered at retail.
